Fisuel : Introduction

- The idea of FISUEL arose in France (2000/2001)
- Because electrical safety is a common concern of great importance, shared by many countries
- In February 2002 – in Beirut – the representatives of CONSUEL (France), FENIE (Spain) and CERTIEL (Portugal) gave birth to the federation.

Fisuel : Facing challenges

- Electricity is playing a stronger and stronger role in our world
- Increasing needs, but installations are not always updated
- Electrical installations and products are getting old
- Proliferating fake products, dangerous for users of electricity

Fisuel : Goals

- To encourage the compliance of electrical installations with the Standards.
- To influence governments in order to have their national regulations revised and updated
- To promote the principle of verifications of the installations before their connection to the network.
- The implementation of compulsory technical periodic and or regular inspections of installations in older dwellings
- To share experiences, best practices, compare methods and procedures so as to improve electrical safety.
- To fight worldwide against dangerous and fake products or components
